WHEN SHOULD MY CHILD START KINDERGARTEN?

- **3-year-old Program:** Your child **MUST** be 3 years old before commencing. *Enrolments for children who have not turned three by the beginning of first term will be accepted, but they are UNABLE to attend until after their 3rd birthday.*
- **4-year-old Program:** Your child **MUST** turn at least 4 years old by 30th April in the year they commence.

Please note that from a developmental perspective, it is often beneficial for children to start kindergarten later rather than earlier. Most children turn four during their 3-year-old Kinder year and turn five in the year before school. Children starting school in the year they turn six, generally have stronger social and emotional skills.

Children cannot do a second year of a 3-year-old funded program. 4-year-old Kindergarten is also funded for one year only, unless there are extenuating circumstances and the child meets eligibility requirements to do a second year.

IF YOUR CHILD'S BIRTH DATE IS BETWEEN JANUARY 1ST – APRIL 30TH PLEASE CONTACT US TO DISCUSS WHICH PROGRAM WILL BE BEST FOR YOUR CHILD.

Your child may also be eligible for Early Start Kinder, where they can access 15 hours of funded kindergarten for 2 years before school. Please contact us to discuss this further.

- **Birth Certificate:** a copy of the child's birth certificate or suitable evidence of the child's birth date must be attached with this application form.
- **\$30 Administration Fee (non-refundable):** this must be paid upon application. Payment can be made via cash or direct deposit: **Manchester Preschool. BSB: 633-000 Account: 128 928 207.** Please use your child's surname and the group (3yo or 4yo) as reference. *Eg: Mackenzie 4yo*

You will be sent notification within 2 weeks that your application has been received. Offers of Enrolment will be sent from June and the enrolment deposit and immunisation statement will then be collected to secure your child's place in the program.
